Project Updates

The new development, at **171 North 1st Street**, is taking shape in Williamsburg, Brooklyn with an estimated completion date in 2023. The building will feature 57 units ranging from studios to three-bedroom apartments along with 7-penthouses and 3-townhouses. Select units will feature private outdoor spaces, and amenities include a fitness





center, lounge, children's playroom, and onsite parking spaces. Currently the terra cotta is being introduced on the facade, displaying the building's chic and contemporary design. Roofs are in the process of being prepared for flood testing and paver installation while all MEP roughing is complete.



MEPA

BCG has been managing the restoration and preservation of **351 W. 14th Street**, a historic landmark located in the heart of Chelsea, steps away from the Meat Packing District. This project requires gutting the interior and mobilizing the original exterior's bricks to a safe location, for reuse to preserve the facade as much as possible. Currently BCG is in the process of transporting steel, along with creating mockups for rebuilding the facade, which are awaiting approval. We are optimistic that upon completion, **351 W. 14th street** will be a reminder of the rich offerings and heritage that this neighborhood has to offer.



The North at 526 Union Ave

Located in Williamsburg, **The North** embodies the chic elements of the neighborhood elegantly fusing art, culture, and style into one unified utilitarian design. Comprising of 44 condos, with most of the units featuring a private outdoor space including state-of-the-art Monti Alpi Island grills. Amenities include a fitness center, rooftop terrace, and parking spaces with EV chargers. The project was well executed with elegance, practicality, and technology at the core of its design, setting **The North** as the benchmark for comfort, innovation, and brilliance.



Gowanus

Located in Brooklyn, **Gowanus** consists of a multitude of projects positioned on **577-581 Union Street, 300 Nevins Street, and 251 Douglass Street.** The project is currently in the beginning stages with major progress underway. Remedial work, scoping, leveling, and buying of all major trades are close to completion, with an approximated groundbreaking in the fall for the Nevins Street location. The project is off to a great start with an estimated completion date in 2024.



Brooklyn Navy Yard

BCG has been assigned to refurbish building numbers 50, 3, 280 and 5 at the **Brooklyn Navy Yard**. The business hub will be a great location for manufacturing, retail, storage and distribution and a creative space for modern day content creators. Currently the project is undergoing fire safety installations including fire alarms, fire pumps and sprinklers.

BCG has completed the pile and foundation phase for **351 East 10th Street**. Mason and plank contractors have been mobilized to begin the erection of the building. Currently the structure is up to the 4th floor and is scheduled to erect a floor a week. Coordination of the MEP trades is about 90% complete with all major shop

drawings, kitchens, windows, and elevators approved. Windows have been released for fabrication and the elevator will follow suit in the next month. Major progress has been made and BCG will continue its efforts to ensure that the project is on time and exceeds client's expectations.
